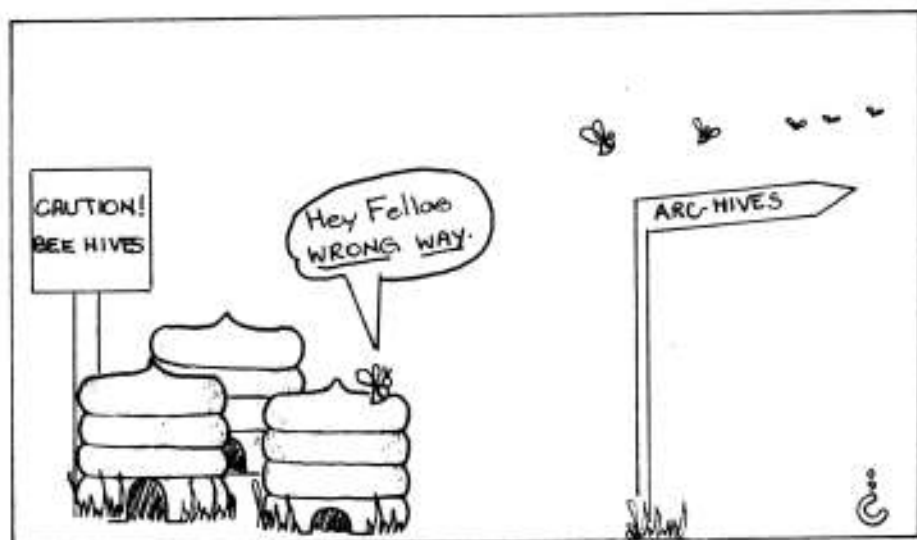

In the last issue I mentioned that I would be attending an Irish Origins Conference at Dublin and Kilkenny. This proved to be a most memorable event and was a well-mixed blend of social activities, addresses, discussions and visits to centres of genealogical and historical interest. The Irish are proud of their Australian connections and are most eager to show visitors what records their various repositories hold.

Most members would be aware of the existence of the Clare Heritage Centre. So successful has this been in assisting genealogists with their research, that others are being formed or are mooted for other counties. I visited one such at Bandon in Co Cork where a team of about twenty young folk are being employed under a job training scheme to index and collate, under supervision, information from church records.

Morning teas and lunches at the meeting venue and the dinner held on Saturday night enabled members from the various branches to mix socially, discuss branch activities and genealogical research in general. This should prove of inestimable value in developing that spirit of understanding and cooperation so necessary for the continued development and expansion of our Society.

At the dinner, Mrs Barbara Payne, from the Bi-centennial Committee spoke about various aspects of the Committee's work and mentioned some grants which had been made to genealogical bodies throughout the country.

All members, particularly those who attended the Council, should be most

grateful to Pat Harris and her helpers for the sterling efforts they made to ensure the weekend was a success. Congratulations and my personal thanks.

What of the future? Members please give the matter of Annual Council some thought. We need early input so that future A.C.M.'s can lead the Society from strength to strength by building on the solid foundation laid in Launceston this year.

Of course everybody knows Tasmania used to be Van Diemen's Land and part of N.S.W. but did you realise that there have been three Irishtowns and two places called Lymington. Towns which once flourished now do not exist while others which were planned and named (e.g. Auburn) failed to develop. Waratah (Mt. Bischoff), now a skeleton of its former glory in its hey-day supported a large population. THE AGE OF CONVICTS?

Maree Ring writes:-

The oldest male convict is thought to be Charles O'Neill, aged 77 when he was transported per 'Navarino', arriving 1843. Mary McAllister is thought to be the oldest female convict aged 75 and transported per 'Phoebe' arriving 1845. Youngest female convict thought to be Mary Ann Goulding age 13, arrived on 'Edward' 1840 and youngest males were John Sullivan per 'Joseph Somes' in 1846 and James Lynch per 'Equestrian' 1844, both aged 9. (Information from general subject index Archives Office of Tas)

Has anyone found any convict older or younger?

Correction: Cheryl Griffin states that her ancestor Kitty Hunter, who as convict Catherine Fitzgerald arrived 1853, died in 1920 aged 100 years 3 mths. (Cheryl wrote a delightful article about this convict ancestress in Tasmanian Ancestry in September 1983. Ed)

PS: Member Joyce O'Shea is descended from John Daniels who died 1910 aged 104.

OCCUPATIONALLY SPEAKING

Arthur Whitton, 1861-1932

My great-grandfather was born on 30 March 1861 probably on his parent's farm at Little Oyster Cove Rivulet (Kettering). He was baptised at St. James' Catholic Church, Port Cygnet, on 16 February 1864 in a double ceremony with his sister Catherine (Kate). The officiating priest was Father James Holehan, and the sponsor Margaret Gleeson. Arthur was the fourth child and youngest son of James Wheaton (sic) and his wife, Bridget Lewis, both early settlers at Little Oyster Cove on land rented from Crouther and Pybus.

For readers interested in social history, James Holehan was a Carlow graduate and appointed as parish priest in 1863 when the Cygnet parish was created. He was left a small church, constructed of local timber which seated about 250 parishoners. At this time, the parish extended from the East bank of the Huon River, around the Channel coast to Snug.

The "Tasmanian Catholic Standard" of 1 July 1867 noted that the Huon District at that time and earlier, was far from a pleasant place to live, being noted for rough behaviour, crimes of violence, drunkenness. The report drily comments that "the roads from Port Cygnet to Oyster Cove" were "anything but what they ought to be".

Other contemporary newspapers also refer to the riotous living of the splitters and sawyers in the Channel area. Good wages, resulting from a high demand for the timber, palings, shingles and other wood products, meant that many early settlers were able to exceed their dreams of substantial weekly wages. Arthur and his brothers participated in the trade, but history has not told of fortunes won or lost.

Following a childhood and adolescence most likely spent on his mother's and stepfather John Burn's farms at Little Oyster Cove, Arthur married Emily Louisa McGaughan at St Joseph's Church, Harrington St, Hobart, on 24 July 1888. From this date his varied occupations are more easily traced.

Arthur gave his age at marriage as 26 years, and described himself as a labourer. Emily was aged 28, and was living with her parents. The McGaughan family were old settlers at Sykes Cove, North Bruny Island, having taken up land there in 1825. A mature English oak marks the site of their farm, "Oakwood", now adjacent to the new road between the ferry terminal and Barnes Bay.

Shortly after their marriage, Arthur and Emily rented a small farm on the western shore of Sykes Cove. The 1890 Valuation of Kingborough notes Arthur

Whitton living in a dwelling on three acres of land, renting from Mrs Jane Harwood, at six pounds annually. He is also shown as owner of a hut and 10 acres at Oyster Cove. The 1895 entries for the Barnes Bay farm are similar, although he is now renting from Patrick Harwood's Estate; the Oyster Cove Land is not shown.

In 1902, Arthur's last year of occupancy of the Barnes Bay property, it is shown as four acres, with house, having a capital value of one hundred pounds. In 1903, it was taken over by George Sward, who purchased freehold from Pat Harwood's Estate.

The Whitton farm on Bruni Island was a typical smallholding for the times, when small farming was coupled with other occupations. The buildings consisted of a four-roomed timber house on brick or stone foundations, a good sized barn, and a pig sty. These stood on a fenced paddock of four to five acres.

Livestock were shipped in by barge. Unless there was a small jetty, or the animal was particularly valuable, stock were generally unloaded over the side into shallow water, and guided to shore.

After the Whittons left, the property was purchased by George Sward and eventually incorporated into "Lennonville".

In addition to the Sykes Cove farm, probably run on a day-to-day basis by his wife, Emily, Arthur was engaged in barging livestock, wood and farm produce between the Channel country and Hobart. He gave his occupation as 'mariner' on the Birth Certificate of his third child, my grandfather, Arthur (Jnr) in 1891. The indications are that he took up this calling shortly after his marriage in 1888. He owned the barge "Luck's All" from 1888 to 1893 and then the ketch "Brothers" between 1893/4-5. As these barges were often not registered, and changed hands regularly over a handshake, the dates of ownership vary. A. Whitton appears in Norman's "Pioneer Shipping of Tasmania" as the owner of "Brothers" in 1902.

A resume of the history of these barges which played such a significant part in the lives of the Channel families, is interesting enough to include.

LUCK'S ALL: Originally 'Nautilus', built in the Huon 1852; 10 tons. Name changed 1853 following a capsizing resulting in loss of three lives.

May have had lee-boards originally, but ketch rigged later for wood trade. Registered 1900 to Jack Sward and wrecked South Arm after that.

BROTHERS: Built 1877 possibly by John Wilson at Cygnet. 20 tons. Date of register 1877. Original owner William Marchant of Huon who completed a Declaration of Ownership 1889. Arthur Whitton believed to have purchased the ketch about 1893. The vessel, like most of the barges, capsized several

times. My grandfather Arthur jr, recalls a capsized near Green Is during his father's ownership, confirmed by O'May as being 1905.

Although there is little other than oral evidence, both Jean Haigh (a descendant of McGaughans) and myself consider it likely that members of the related Channel families usually crewed each others barges. There are strong family connections between Whittons, Swards, McGaughans, Harwoods and Lucas families. In times where diversity of occupation was more common than now, the Victorian concept of the extended family was of significant value.

Much of the barging done by Arthur Whitton involved a contract with the O'May family to supply cut timber fuel for their steamers. The wood was cut from the slopes of Roberts Hill, south of the Whitton farm; an area which was densely wooded. The barge was loaded at the nearest suitable point. Frank Whitton, Arthur's brother, had a farm at Trial Bay, but was often known to row across the Channel to help Arthur cut timber.

Wood cut on Brunl and elsewhere for the O'Mays was either barged to Hobart or stacked on a framework at the west end of Little Oyster Cove. The remains of the pilings could still be seen up to ten years ago. One benefit of direct barging up to Hobart was that the steamers would often throw the wood barges a line and tow them to the ferry wharf at Bellerive where the wood was unloaded.

Back on Brunl, the barges used to lay up under Wisby's place, (the old Quarantine Station) on the north shore of Barnes Bay; or close to the original ferry wharf. It would be impossible to underestimate the importance of the Channel barges to these early settlements. They filled the role of present-day roads, at a time when highways were rough. The men who sailed them usually retained a small holding, or were part-time sawyers or labourers. They rarely had formal training, but from experience became competent mariners, well able to load their vessels to the gunwales and support their community with a vital service at some small profit.

Many barges, though well handled, capsized or ran aground. My grandfather spoke of seeing waves break on deck on his father's barge "Brothers". On one occasion while bringing wood up the Channel, Arthur sr was knocked overboard by the boom. In common with most, he could not swim, and was weighed down by clothing and boots. His uncle, James McGaughan, brought the ketch about and as they came up to where he was still struggling to keep afloat, Jim McGaughan reached down, grabbed a handful of hair, and hauled him aboard.

Around 1901, Arthur and his family moved from Bruni Is to Sandy Bay, where Arthur had purchased several properties in Queen and King Streets over the previous 10 years. By 1924 Arthur owned eight freeholds here, some being retained for family use and others tenanted as investments.

Arthur, until this time a sawyer and wholesaler of wood, must have realised the retail potential of the trade in a developing Hobart community, as he established a wood yard in 1903. Initially, the business operated from 49 King St, Sandy Bay. In 1914 he relocated to larger premises at 61 King St, where the yard remained until closure.

The business prospered, first under Arthur then traded under the partnership of "Whitton Brothers, Fuel Merchants". This consisted of the partnership of three of his six children: Jim, Ern and Arthur. Ern's sudden death in June 1958 together with the steady decline in demand for solid fuel as electricity and gas heating became more popular, were the reasons for closing the business about 1960. Older readers may remember the family and Whitton's Woodyard on the south side of King St, just up from the Post Office. The site is now a shopping centre carpark.

Arthur sr, retired wood and coal merchant, died 3 October 1932, peacefully at his home at 54 Queen St, Sandy Bay. His death notice in the 'Mercury' also described him as Master Mariner. During his lifetime he had variously been a labourer, sawyer, farmer, mariner and wood merchant. It was this diversity in his life's occupations which, in such contrast to our contemporary emphasis on specialisation, prompted this article as a practical illustration of how the detail of occupations, business interests and consequent family ties are able to add an extra depth to our genealogical research.

BIRD & McCARTHY:

A reunion is planned for Sunday, 4 September 1988 at the Football Grounds Karoola, Tas., for the descendants of James and Ann Bird, and Cornelius and Margaret McCarthy.

The 25th August 1988 marks the 150th anniversary of the arrival from England of James Bird - the first of our ancestors to arrive in Tasmania.

James married Ann RICKETT at Launceston in 1844, and their children were:- Jane b 1844; Ellen b1850, m Charles MORSE; Charles b1852 m Sarah McCARTHY; and Mary b1857 m John McCARTHY.

Cornelius McCarthy arrived from Ireland in 1841, on the same boat as his future father-in-law Richard CLANCY) and in 1850 married Margaret Clancy, who had arrived from Ireland 1849 with her mother, brother and sisters.

Cornelius and Margaret's children were:- Mary b1851 m Michael McGREE; Cornelius b1852 m 1. Mary Ann BARRETT and 2. Jane SAUL; Sarah b1853 m Charles BIRD; Daniel/Richard b1855 m Mary RYAN; John b1859 m Mary BIRD; and Anne b1861 m Richard GRIFFIN.

It was with regret that I learned of the death of His Excellency, the Governor Sir James Pflimsohl. Past President Doug Forrest and his executive initiated the move to have the Society brought under Vice-Regal patronage and a few months after I assumed office the Late Sir James agreed to accept the position of Patron.

On the year ended 31 March the membership of the Society increased from 799 including 167 overseas and interstate members, to 911 with 157 from outside Tasmania. This represents an increase of 122 Tasmanian members and a decrease of 10 others.

Financially the Society is in a sound position with a credit balance in excess of \$18,000. This includes all funds administered by the Executive and branches. The fact that branches have incurred considerable expenditure in acquiring equipment and materials for branch library expansion, and yet show a credit balance, is an indication of the enthusiasm of fund-raisers. Through the efforts of retiring Exec. Treasurer Geoff Rapley and branch treasurers, the financial structure has been modified to meet the requirements of the Corporate Affairs Commission.

The fact that under articles of incorporation it was necessary to tighten audit procedures followed during previous years, has led to the appointment of Coopers and Lybrand as the Society's auditors. This was an expensive exercise and the decision was undertaken only after lengthy deliberation. Such expenses were foreshadowed in last year's Annual Report. However, should members consider the expense to be unjustified, it is in their hands to recommend an alternative.

Whilst on the subject of finance, and with the certainty of increased prices and charges in the future, it would seem desirable that serious consideration be given to the formulation of a long term budget to take into account the future expansion of the Society as a whole so funds are spent to best advantage.

That each branch has been active in promoting the aims of the Society is evident from the growth in membership, participation in tutorial activities and enthusiasm of members. Individual branch reports indicate the extent to which this has occurred.

A most noteworthy event of the year has been the main Library's occupation of its new premises after such a long wait. Lillian Watson and her Hobart Branch helpers are to be commended on the time and effort given to ensuring such a smooth transition. Regret must be expressed that Theo Sharples, due to illness, had to relinquish her position as librarian prior to this event.

Another pleasing aspect of the year has been the expansion of branch libraries

both in services and variety and amount of research provided, much of which is due to the energy and enthusiasm of branch librarians.

Research enquiries from all areas have increased and queries have been dealt with efficiently by Research Coordinator Bev Perkins and her branch counterparts.

TAMIOT work has continued unabated due to the untiring efforts of Vernice Dudman and branch officers. These records are invaluable to genealogists and it is imperative that information from such sources should be recorded before the ravages of time cause irreparable loss or damage.

Audrey Hudspeth and her team have continued to produce a quarterly journal of high quality in content and format, and Jean McKenzie has ensured that members received their copies regularly. Their efforts are greatly appreciated. Congratulations also to members who have given time and thought to the preparation of articles submitted for publication.

Registrar Margaret Parssey and Membership Secretary Helen Anderson have continued the onerous task of keeping the membership register up to date, and Public Officer Jim Wall has devoted time to liaising with Corporate Affairs officials to ensure the Society adheres to the requirements of the Incorporation Act.

Thanks to Neil Chick, work on the VDL Index has continued and when completed, this will become a major source of information for genealogists everywhere.

After a lapse of some time, inter-branch library, TAMIOT and research meetings were resumed. These enabled participants to gain a greater knowledge and appreciation of the work of each section. Further such meetings will result in greater cohesion and cooperation among branches.

The Society has agreed to host the 1991 Australasian Congress on Genealogy and Heraldry but for this to be a success, planning must commence soon. Some preparatory work has already been undertaken by a committee headed by Pat Harris. The Society has made \$1,000 available for initial expenses. For the venture to succeed, all branches will need to furnish firm promises of commitment. I am confident that within the Society there is the expertise and endeavour to stage a successful Conference, and bring national and international awareness of the progressive genealogical work being done in the State.

When asked to take office as President twelve months ago, I felt very diffident because of the high standard set by the previous incumbent, Doug Forrest. Now

I feel I should have achieved more. It was my intention to visit all branches, but a late decision to travel overseas to the Irish Origins Conference caused me to miss one. My apologies to Hobart Branch for this omission. It was both pleasurable and instructive to meet branch officers and members and to discuss their problems and aspirations with them.

In conclusion, I offer my sincere thanks to all members for their support and to my executive for the many hours of concentrated effort they devoted to the Society's business, for their assistance and tolerance of my inexperience. Especially I thank John Grunnell for performing his exacting task as Executive Secretary so efficiently and to Geoff Rapley for his dedication to the Treasury. I am confident that 1987/8 will see continued expansion of the Society and growth in all aspects of its involvement.

Library Notes

The Library for the Hobart Area is situated at 19 Cambridge Rd., Bellerive (the former PO building). Opening Hours: Wednesdays 9.30am to 12.30pm and 7 to 9pm. Saturdays 1.30pm to 4.30pm. The third Tuesday of each month except December and January, 6 to 7.45pm, so that members can visit on their way to the meetings which are held a few doors away.

The Library Committee holds a business meeting one month and a Committee Workshop the next month, with a special daytime Workshop on the SECOND TUESDAY OF EACH MONTH, 10am to 2pm. Your assistance at workshops or on other days, even at home, would be most welcome. (Phone 002-442504)

Thank you to the generous donors of money, books, maps, manuscripts and charts. Sometimes I find a bundle of material on my desk which does not reveal the name and address of the donor.

Mr. Hugh Campbell presented the Library with Forty Thousand Forebears of Neil Hugh Campbell and Mary Kathleen Goss. Included surnames are Vincent, Rosevear, Burton, Dorgan, Gould, Connell, Double, Flaherty, Campbell, Steer, Triptree, Goss and Rasmussen, plus many background records.

The Mercury indexes to Births, Marriages and Deaths have been microfilmed and are being sorted into three sections, pre-1900; 1900 to 1927; and 1928 onward. Take care until the division is complete.

Many researchers are finding microform copies of records from the NSW Archives to be very valuable. These include some early NSW Convict records, some for Free Passengers, Naturalization, and Land Grants, Church Registers of Births, Marriages and Deaths in NSW to 1856 and indexes only after that date.

Indexes to B, M, D in other States, mostly prior to 1900, are also available.

The Subject file SCOTLAND, holds an updated list of records held by the General Register Office of Scotland and the current prices for certificates.

A new supply of Family Record Binders is on hand, also books on Newcastle, NSW and N.Z. sources. A new book on S.A. sources by Andrew G. Peake is being ordered and should sell for about \$18 each. Orders will be accepted.

A list of people who wish to obtain twice yearly the Family History News and Digest (\$3) from U.K. Federation of F.H. Socs, is being remade. Unless your name is down you could miss out. This is a must for all those who have UK searches to do. Some old copies are available for \$2.60.

Information from Newsletter Issue No.2

Over the last few months, the membership of the Association has increased considerably. The increase reflects the interest Aboriginal people have in their own culture and history as well as the desire to maintain family associations.

TAGHA's staff have been working overtime to answer the many requests for information which have arrived from as far away as Queensland and Western Australia. At this stage it appears there is much more interest in family histories. However, we have also received several enquiries on culture and language.

Language is an important part of Aboriginal culture and is an area which deserves a great deal of attention if Australia is to retain the unique diversity of traditional languages.

Aboriginal languages have, over the last 20 years, suffered a decline in Australia. The effect of Western culture on young people in remote areas as well as the loss of many older speakers has meant some languages are in fact dying out.

TAGHA, along with other Aboriginal groups, has approached the Federal Government requesting that some consideration be given towards funding a program which will record and preserve the languages still surviving today. I am pleased to be able to report at this stage some progress is being made. The Minister responsible has set up a committee which is now interviewing Aboriginal groups around the country in order to assess the extent of assistance necessary.

The languages that developed in Australia over the last 40,000 years are nothing less than National Treasures. They are worth preserving for the following generations just as old buildings and other reminders of the past are worth looking after.

BARREN ISLAND

Most Tasmanians know where Cape Barren Island is but how many know anything about Barren Island?

Some months ago, I was doing research at the Archives on the group of people known as the Straitsmen, when I came across a number of births and deaths which indicated Barren Is. as the location. I hadn't heard of such a place and started looking at maps and making enquiries at the State

Library. Library staff consulted the card index but no Barren Is.

It wasn't until I discovered a copy of a VDL map which was drawn from the original M.S. Surveys, in the Colonial Office, and VDL Company Office, that I discovered where it actually was.

Barren Is in the Hunter Group was visited many times by Aboriginal people who were either sealing or in search of mutton birds. Often births and deaths can be checked off against hunting seasons to build up a pattern of visits.

THE STRAITSMEN

The Straitsmen are those intrepid people who brave the Bass Strait weather and isolation to live on the islands between Tasmania and the mainland, many of whom are Aboriginal people still living where their ancestors lived for much of the past two hundred years.

Most of these people now live on Cape Barren and Flinders Is. There was a time when they were spread right across the island group from the Furneauxs to King Is. They made their living as sealers, boatbuilders, fishermen, farmers and sailors. The history of their past firmly identifies them as Tasmanian Aboriginal people today.

TRUGANINI

A number of enquiries have been received from people who believe that they are the descendants of Truganini. However, when their family history has been checked, no such connection can be found.

Truganini died on Monday 8th May 1876 at the corner of Macquarie and Harrington Streets, Hobart, where the Town House Hotel stands today. She had no children and no surviving relatives at the time of her death. It is therefore not possible that any person can claim descentance from her.

Truganini was not the last Tribal Aboriginal Tasmanian. Two other women were living at the time on Kangaroo Is., South Australia. The first to die was Betty who passed away in 1878 followed by Sukey in 1888. Dockets 280 and 1894 of the Destitute Board of South Australia indicate the above details. (Ellis V.R.)

Convict Research

by Maree Ring

Do you think you have convict ancestry?

A fairly clear indication might be found on death certificates, especially those from other states that indicate a period of residency occurred in Tasmania, especially if that period was six or seven years (which might indicate a seven year sentence), nine or ten years or fifteen years indicating possible longer sentences. Often one year was spent in gaol or on hulks before the three month or longer, journey to Van Diemen's Land. Many convicts served their time then ventured to the mainland and New Zealand to lose the convict stigma.

The convict records are kept by the Archives Office of Tasmania (A.O.T.) who will answer limited written queries or refer you to a private researcher. (Archives and Genealogical Society of Tas both have lists).

If you visit in person, you will find the A.O.T. at 91 Murray St, Hobart, entrance through Reference Library to lifts which will take you to the 10th floor. On entering, you will be required to sign their visitor's book.

The Archives staff will check their indexes to convicts. If they married in Tasmania (and this information is on many state certificates of birth) ask the staff if they will also check the permission to marry indexes, giving names of both parties. This could simplify research as often the ship of arrival and date of permission was noted.

The staff will give you a number which corresponds to the ship of arrival noted in the Convict Index Book located on the desk. This will give the date of departure from UK or Ireland and arrival in Tasmania; or if locally convicted, the transportation to Norfolk Island; and reel numbers for the microfilms giving convict's record, indent and description. Don't forget to write CON before the number or you might end up with a RGJ film!

The convict record contains date and place of trial, what type of court (QS = Quarter Sessions; A = Assize; CCC = Central Criminal Court, London, are a few abbreviations used); original crime and sentence plus any earlier minor offences and sentences, gaol or hulk report, marital status, literacy and religion (not shown on all records especially early ones); any further offences once here and resulting punishment, date of Ticket of Leave (T of L), Conditional Pardon (CP), Free Certificate (FC). Some very early records do not show actual reason for sentencing and this can be found by referring to Australian Joint Copying Project (AJCP) reels as listed in the handbook Part 3 (HD 26/2? Criminal Registers Series I/II respectively) again held by AOT staff at the desk - needs to be asked for. Some later records give

a personal description (equivalent to present police file photographs) and native place (place of birth). The earlier records give this separately on another reel of film. Later descriptions can contain names of family members (next of kin) and their place of residence, though this is often limited to native place (NP) or other town, if they have emigrated, especially to America. ADT have leaflets available for records CON 31,40; 33,41 and 14,15, with explanations of and abbreviations used in the records. If the convict had already been married, ask if there is any record of him/her applying for family to come out.

Some number of convicts have the same names. In these cases a permission to marry may expedite the research, though for some it may be a slow process of elimination - death before or on arrival; wrong age; too early or too late in arriving .

Once place and date of trial have been established, writing to the appropriate County Record Office in England may unearth further information regarding the trial. Tracing Your Origins by Angus Baxter, lists these addresses and likelihood of available help. Some cannot always give the help sought and will send a list of private researchers. Some offices charge fees, some have sent their records to the PRO London, and then a personal visit or private researcher is needed.

You should send return postage: English stamps for England, Wales and Scotland are usually available from GST library, Bellerive. When writing, give name of ancestor, date and place of trial. Ask if transcription of trial is available or any other information concerning the trial. Also ask them to check for a newspaper report of the trial, and if there is a charge for the above research.

PLEASE NOTE: often date of trial given on a convict record is the first day of sitting for that session. Sometimes the actual date of sentence is not for a week, fortnight or even later).

LEAFLETS: When and How to Secure Professional Help; Preparations for Overseas Research and Research Planning, Evidence and Evaluation are available from GST and may assist you.

SCOTLAND: New Register House, Edinburgh is the place to write - (I obtained a copy of the full trial of my only convict ancestor from this source).

IRELAND: State Paper Office, Dublin Castle, Budlin, holds the Irish records. (I've had no luck here but another searcher has a full trial from this source). Try local county libraries for newspaper reports. (International Reply Coupons, IRC's, available from post offices if Irish stamps not).

AVAILABLE LOCALLY: Some 1820's/30's trials of Central Criminal Court (CCC) London have been published and are available in the Tasmaniana Library

(indexed under London Central Criminal Court in the indexes to the left after entering this collection.) The Allport Library and Museum of Fine Arts also holds some transcripts of trials at the Old Bailey (CCC). These run from 1799-1801: 1803 (one yr only) and 1816-1823.

Some trials, even from other counties, have been reported in the London Times - available in the Serials Section, 3rd Floor, State Library, Hobart.

SURGEONS REPORTS: Now that you have sought and found your convict ancestor's record, description etc (see also "Searching for your Convict; A Guide for the Beginner", Tasmanian Ancestry June 1987) it would be well worth looking in the convicts ship book at Archives to see if the surgeon's report (second last column) has survived the ravages of time.

These records are kept by the PRO, Kew, England, and have been microfilmed and are available under the Australian Joint Copying Project. Copies of the films for vessels that came to Tasmania are held by ADT. Other copies are held by National Libraries, Canberra and Wellington.

Some surgeons reports list those who were sick noting illness, date of onset and cure or death; some more serious cases are described in detail with symptoms and treatment being recorded; preparations and conditions of journey from England or Ireland to VCL. All the foregoing reports are not always available for every surgeon's report. Beware, I also know of one written in Latin! Charles Bateson's book "The Convict Ships" is a valuable source of information.

It was possible for a female convict to bring children with her, and any illness on the voyage would be noted by the surgeon. On arrival, the child if very young, would be kept with the mother until it reached an age where it could be admitted to the King's/Queen's Orphanage. Records are held by ADT, are indexed and begin in 1828.

JOHN KENNEDY'S LEGACY

Irene Schaffer

Have you ever come across an article in a newspaper that you found interesting and wished you knew the beginning of the story and how it ended? The following item is one I found and promised myself that one day I would follow it up. The article had been cut out of the "Argus" dated 17 September 1932 and placed in a scrapbook which was later given to the Tasmanian Archives. (N52/26/1)

Redress after 108 years
Former Convict's Will
Estate of 10,000 pounds

Adelaide, Friday - How a former convict transported to Tasmania for embezzlement of his master's money attempted to make redress in his old age, by leaving half his Property to his former employer's wife, was told in the Adelaide Civil Court today, when Mr Justice Angas Parsons was asked to decide who was entitled to the estate of John Kennedy, who died at Golden Grove (SA) on May 21, 1870. The estate, which was worth 1,000 pounds when Kennedy died, was valued at 10,000 pounds about 5 years ago when his daughter died without issue.

In the event of his daughter dying without issue, testator left half his estate to a Mary Hathaway and the other half to John Kennedy, Paper Stainer of England, whose whereabouts have been traced. The Affidavit of one of the claimants who stated that he was a great grandson of Mary Hathaway, alleged that John Kennedy was tried at the Old Bailey, London, in September 1824 for embezzling and was charged with having embezzled 37 pounds 3 shillings and 6 pence and 25 pounds from his employer, James Thomas Hathaway, said to have been the husband of the Mary Hathaway mentioned in the Will.

Official records showed that Kennedy was sent to Van Diemens Land in 1826. A customs book entry at Port Adelaide showed that John Kennedy and his wife were amongst the passengers who had arrived by the Schooner "Tamar" on the 14th March 1838.

Mr Justice Angas Parsons found that the persons entitled to the estate in equal shares were the issue of Mary Hathaway who lived in England.

Trying to find a convict called John Kennedy was slightly hampered when I discovered two by that name had been transported to Tasmania. One was in 1825, the other 1826. On studying the two records I soon omitted the 1825 one because his sentence didn't tally with the one I was seeking. The John Kennedy in the article arrived in Tasmania on the ship "Earl St Vincent" on 13 August 1826. He was tried at Middlesex on 16 September 1824 to 14 years for embezzlement. His gaol report stated he was well behaved, conscientious and respectable. Hulk report was good and his Native Place was N.S. City Road, London. He was a Protestant and single, a paper hanger and house painter and 21 years old. (CON 31/27. CON 13/3. CSO 1/29/502)

After arriving in Tasmania, John Kennedy added a few more charges to his record. In 1829 he stole 40 yards of silk and other property. On 2 January 1830 he was insolent and disrespectful to Capt Vickary and was sent to the chain gang at New Norfolk for six months.

In 1836 he received permission to marry Mary Herring and they were married by Banns at New Norfolk by W. Garrard on 11 January 1836. (3492/1836)

Mary Herring was tried at Middlesex in 1830 to 7 years transportation to Tasmania. She arrived on the ship "America" in 1831. She was tried for stealing three table cloths. No gaol report, and she was single. She had no further convictions after she arrived (CON 40/5)

The remainder of John Kennedy's sentence was remitted and he was permitted to proceed to S.A. with his wife Mary in the service of Mr Ansley.

From here, the story could be continued in SA to discover when their child was born etc.

My reasons for writing this article were firstly that I found it interesting, and secondly, I believe we are not using our newspapers to their best advantage. Not only can there be found stories like this one; they also can help with information about our ancestors. Below is a list of sources that newspapers contain.

1. Births, deaths, marriages (often from other states and England)
2. Obituaries (and articles, if they died attaining a substantial age)
3. Police reports
4. Lists of convicts who have received their Ticket of Leave, Pardons and Certificates of Freedom.

8. Inquests
9. Land records
10. Subscription Lists (donations for churches etc)
11. Shipping arrivals and departures (for passenger lists)
12. Advertisements
13. Entertainments (theatres etc)
14. Photos of people and places (especially Tasmanian Mail)
15. Public House Licenses
16. Military arrivals and departures etc.
17. Sport (horse racing often gives name of horse owner).

is open to all interested in Genealogy, whether resident in Tasmania or not. Assistance is given to help trace overseas ancestry as well as Tasmanian.

Dues are payable each year by 1 April. Rates of subscription for 1987/88 are as follows:

- Ordinary Member : \$20.00 per annum
- Joint members (Two persons at one address) : \$26.00
- Student/Pensioner/Unemployed over 6 months : \$13.00
- Joint Pensioners : \$20.00
- Corporate Members (Institution or Society) : \$24.00

Membership entitlements include receipt of the Society's journal, TASMANTIAN ANCESTRY. (NOTE: Air-mail postage is extra). Members are entitled to free access to the Society's Libraries, and reduced rates for purchase of some other publications. Access to the libraries of some other societies has also been arranged on a reciprocal basis.

Application for Membership forms may be obtained from Branches or the GST Secretary and be returned with appropriate dues to a Branch Treasurer, or sent from out of state to the GST Treasurer, Box 6400, Hobart, Tas. 7001. Dues will also be accepted at Branch General Meetings or at the Libraries.

The MAIN Library is in the old Post Office at the corner of Cambridge Road and Queen Street, Bellerive, and other branches at Huonville, Launceston, Devonport & Burnie, also have libraries. Access is free to members, but there is a charge of \$3.00 each session to non-members at the Main Library & All users of Microfiche or Microfilm Readers are charged \$1.00 per hour extra. Books, journals from various genealogical societies, indexes to transcribed tombstones, indexes to Births, Deaths & Marriages in the 'Mercury' and a register of family names and charts may be consulted at the Main Library, and books, notes and charts may be purchased there.

Donations to the Library Fund (\$2.00 & over) are an allowable tax deduction. Gifts of family records, books, maps, photographs etc. are most welcome.

Research is handled on a voluntary basis in each branch. Simple queries from members will be answered on receipt of postage and self-addressed envelope. For non-members there is an additional fee of \$2.00 for simple queries. A fee of \$5.00 will cover research for half an hour in our own library only. A list of members willing to undertake record-searching on a PRIVATE BASIS can be obtained if records outside the GST library are required. The Society TAKES NO RESPONSIBILITY for such private arrangements.
