If you ever feel a visit to St Catherine's House in London would be an interesting, exciting experience, think again. The excitement wears off rapidly and the interest is continually disrupted by the efforts of large numbers of other researchers who will jump your 'spot' on a reading table quickly and without any beg-your-pardons.

Don't let me put you off though. The rewards are there to find if you can only last the distance; but you should be prepared for the search with the right equipment and not be daunted by the enormous number of books you will need to check to obtain your information.

I found the best way to get to St Catherine's was to go via the underground to Holburn Station and walk down the Kings Way to St Catherine's which is close to Australia House. I reckoned this was the best way because there was an excellent coffee shop on the way where we could fortify ourselves for the coming battle.

Entry to St Catherine's is free. The only contact you will have with the security people at the entrance will be when they hand you a slip of paper warning you about pickpockets and hand-bag thieves. There are signs all over the building warning that your wallet could be in someone else's pocket if you do not take care, and when you think about it, the crowded conditions would attract people who might consider they have more right to your property than you, if you are careless enough to let them.

There are three distinct sections in the rambling building, one each for births, deaths and marriages; and the registers which are stacked three high in open steel cupboards are large and heavy and are jammed quite tightly together. Between the shelves are sloping double sided reading tables, just big enough on each side for the volumes. There is little room between the tables and cupboards and the reading areas are totally inadequate for the number of people using the facilities.

The volumes are arranged in quarters and there will be several volumes for each quarter, depending on the number of events taking place at that time and whether or not the volumes are copies of the originals which are handwritten or have been printed by computer.

Each entry will provide basic information only, the surname, first Christian name and possibly an initial for any other name, the parish in which the event was registered and the registration number. Sometimes

the registration district name does not convey much to the reader as occasionally the old 'hundred' names are used and these can no longer be found on a modern map. However, a code is included in the registration number which will sometimes help you locate the county in which the registration took place. It is stressed that these numbers are not always of assistance, as often the reference number is used for more than one county, especially in Wales.

From 1837 to 1851, Roman numerals were used. From 1852 Arabic numerals followed by a letter were used and from 1946 the code was changed again. I have managed to obtain a copy of the codes used.

The proper equipment to take is a reasonable sized note pad and several pencils. Ink pens are not permitted. I recommend that under no circumstances should handbags or purses be taken in and only sufficient cash in a pocket for train/bus fares and something to eat.

The ventilation system at St Catherine's is poor and even on a chilly day it will not be long before the coats were coming off and discarded. Once again the risk of theft.

When you take a book from the shelf you need somewhere to put it down and space is hard to find.. When you return a book to the shelves, there is no guarantee that you will find your space still vacant when you return to the desk, and there are few apologies given either. Many of the researchers are lawyers checking births etc. to prove wills or properties and other matters and they are quite assertive, although not half as bad as some of the professional researchers who will tell you in no uncertain terms what they think of you. One such woman told Ann that "... Australians are a .... nuisance."

If you need help, you should not ask one of the other researchers unless they can answer you quickly. They are often being paid for their time and will resent the interference. You can get advice from the staff who are quite helpful. It is best to ask the security people at the front door first and they will direct you.

After you have found the long lost relative, you must fill out the appropriate form and join the queue at the cashier's desk. If you pay at the counter, it will cost you five pounds for a full Certificate of Birth, Marriage or Death, or double that if it is applied for by post. In one of those strange anomalies found in public service areas, I applied for one certificate and was charged five pounds even when I pointed out the postage was to Australia. The certificate arrived by air mail in good time.

When the records become available in Tasmania, it might be as well to hire someone to go to the cashier on a regular basis and lodge applications on our behalf. The costs will be halved, and we could pay a commission to whoever did the work for us.

St Catherine's closes at 4.30 and an attendant will walk round telling you to close your books and put them away. One of the ladies was quite loudly assertive and actually took the book from one man who was trying to copy a few words to save a return trip. So keep an eye on the time!

The premises are open from 8.30 am and a full day is enough to provide you with lots of information and often a first class headache as well.

There is no generalisation of names and it might be necessary to search for variations in separate sections of the index. My name, for example, could be spelt Lello, Lallo, Lillo, Liello and others, and to find the lot we would have had to search for a lot longer than we had time for. We did have some success and managed to get some 2-3 thousand names from 1837-1984.

Marriage records after 1911 provided the surname of the spouse. Death records commenced to give the age of the person concerned after 1865. After 1911 the surname of the mother was given for births. The extra small amount of information was helpful in some cases.

You will not get a date of birth, marriage or death from the indexes. You will get the quarter in which the event was registered. This can be misleading. If a person was born or married or died in late March, the event might not be registered until April and would be listed in the next quarter.

Despite all these problems, we found the visits fruitful. In the first instance we did not intend to do as much work as we did, but the weather and other factors combined to make it possible. We have now been able to put together a lot of names and dates which were not completely clear before and our tree is growing nicely as a result.



# *The Human Error*

From time immemorial, the human error has manifested itself in numerous writings but, perhaps more so, in the making of transcriptions and copies. Possibly the monks of old, crouching in their cells or sitting in draughty cloisters, their task the copying of lengthy documents, were far more accurate in their work than we are today. One can well imagine their careful deliberation as they cut their quills to the desired shape and fineness, slowly working away when time was not a premium. These tasks were performed to a standard and perfection which now, regrettably, has been more or less lost. Examination of a great many handwritten documents has convinced the writer that errors therein were minimal. In fact, only in one large manuscript containing several thousand words was an error discovered. This was the duplication of four consecutive words. They were "on the Feast of" and did not affect the reading or intent; rather the error gave emphasis.

By the time the advent of Parish Registers was reached in 1538, the mode of calligraphy had undergone considerable change, much of which did not improve its legibility. An Act passed in 1598 ordered that parchment registers should be purchased by each parish, and that all names should be entered therein from the beginning, but "especially since the first year of her Majesty's reign". It is for this reason that so many registers begin in 1558, the transcriber indolently complying with only the last part of the injunction, but omitting to copy the first twenty years of the original register. What happened to the previous entries is anyone's guess as few of the original paper registers are now in existence. Also it was ordered that entries should be made as before, on Sundays, but in the presence of both wardens. Each page was to be subscribed by them as well as by the minister and finally, it was provided that the churchwardens of each parish should, within a month after Easter each year, transmit to the diocesan registry a transcript of the register entries for the preceding year. By this means it was hoped, among other things, to eliminate deception and the human error.

Many clergymen holding livings were not resident and failed to see that these orders were carried out and often they were brought to task by their bishops. Despite the fact that transcripts were supposed to be scrutinised and signed by the church wardens, it was often left to the parson who reduced the work by omitting such detail in the transcripts so that there are frequently discrepancies between them and the registers. As time went on and the population increased, there were naturally more christenings, marriages and burials and at times an incumbent would be called upon, at

short notice, to perform the act of baptism upon a sick child not expected to survive. Consequently details were perhaps scrawled upon scraps of paper, irretrievably lost or omitted to be entered in the registers.

It is noted in 1883 the files of the Bishop's Transcripts were described as a "lamentable picture of episcopal negligence, parochial parsimony and official rapacity". Fortunately, some clergy were more orderly and punctilious than others.

This leads us to 1837 when it became compulsory for all births, deaths and marriages to be registered. During the first year or so quite a number of persons evaded this measure which accounts for some omissions. However, it is only fair to state that the collection of the many millions of entries housed at the General Registry is most impressive but, nevertheless, there are omissions and cases of human error, some of which may still be corrected.

A friend of mine, a member of the Sussex FHS has, over a period of time, drawn attention to various discrepancies in the Indexes at St Catherine's House. His surname is INCH and this has appeared in various forms including LUCK, JUCK, INCL and SUCH, while the surname CAMDEN was indexed as CALMDEN. He has taken up the matter with the Registrar General and has been successful in having these "human errors" amended. He strongly advises that all persons making out certificates should ensure that the surnames are either typed or printed in block capitals to eliminate graphical errors.

The writer has also come across "human errors" in the International Genealogical Index prepared by the Mormons. Such errors discovered are invariably wrong date or parish. Any entries found on a microfiche should be carefully compared with the appropriate parish register.

To sum up. If you feel certain that the name you are researching should, but does not appear in a register, never omit to compare the register with the Bishop's Transcript and think of alternative spellings which could be brought about by local accent, mis-spelling or perhaps by indecipherable handwriting. Also, if you are unable to locate the entry you require in the indexes at the G.R.O., make a point of trying some alternatives.

Unfortunately, the "human error" will always be with us but, if you have sufficient evidence to prove that a birth, marriage or death should be in the GRO indexes, do not hesitate to write to the Registrar General, who will have the matter investigated and, if satisfied beyond reasonable doubt, have the indexes amended.

# *John Herbert*

## Convict to Settler

At the Old Bailey Session beginning on Wednesday 21 April 1784, 17 year old John Herbert, a native of London, was indicted for stealing one silk handkerchief, valued at one shilling, the property of John Thompson. The offence had occurred on 5 April and the boy had been caught by a witness. The sentence was transportation for seven years.

John was kept a prisoner on the hulk 'Censor' which was moored in the port of London. When the First Fleet was assembled at Deptford on the River Thames, it moved down the coast to Portsmouth, picking up the convicts along the way. John Herbert was one of the 208 male convicts who sailed on the 430 ton 'Scarborough', the second largest transport of the fleet. After many setbacks, the fleet set sail for New South Wales on 13 May 1787 at 4am.

John spent sometime working in the settlement at Port Jackson. Later he went to Norfolk Is where he was employed by the government as a constable. While on Norfolk Is, he had a family to Hannah Bolton. She had arrived in Sydney on the 'Lady Juliana' of the second fleet, and had gone to Norfolk Is almost immediately on 7 August 1790.

In the Norfolk Is muster of 1807, John Herbert was working 12 acres of land and was growing wheat and maize. At this time the Government made plans to remove the Norfolk Islanders to Van Diemens Land. The 'Minstrel' newly arrived from England was one of the vessels used to transport the settlers.

In 1813 John Herbert, with two of his children, James (aged 17) and Elizabeth (aged 13) were amongst the sixty three passengers who embarked on the 'Minstrel'. The evacuees were to receive from 40-80 acres of land each, in an area south of Launceston. The land had been inspected by Gov. Macquarie in 1811 and named Norfolk Plains. Many of the allotments were along the South Esk and Lake Rivers.

When the vessel arrived in Launceston in 1813, the Government supplied the settlers with axes, shovels, nails and hoes. Their goods were loaded onto carts hauled by oxen and they set out for their future home.

Sixteen convicts assisted the settlers in building log and turf huts. The furniture consisted of a rough bench or table, blocks of wood for seats, perhaps a bed and always a chest or box. Most of the cooking was done outside. John and James Herbert each received 50 acres along the South Esk River. Their closest neighbours were Richard Sydes, William Roach, John

Knowland, Thomas Sellick and the White family. Some of the first farmers in this district later known as Pateena, were also First Fleeters. The men were soon occupied in clearing the land and hunting kangaroos, emus, and wild ducks. The women carried water, collected wood, gathered native roots and plants for medicine and started small logged gardens.

The Port Dalrymple Land and Stock Muster of 1820 noted that John Herbert was growing wheat and had 30 acres under pasture. He also owned sixty head of cattle. The Herberts remained friends with the Stevens, Cox, Saltmarsh, Jordan and other Norfolk Is families who had settled in the area.

John Herbert's surviving grand-daughters were Susannah Herbert who married Charles Robinson and later John Williams; Mary Herbert who became the wife of William Holgate of Longford and Susan Chapman who married John Goodyer of Ravenswood. There were four generations of the Herbert family when John died at Longford on 19 November 1846.

Descendants married into the families of Ralph, Wise, Ballard, McGiveron, Smith, Millwood, Hill, Carter, Bassett and Dudman. Present day descendants have the following surnames: Brimble, Griffiths, Forbes, Mickleborough, Hughes, Marston, Swain, Glover, Scarson, Farquhar. ## AUSTRALIAN ARMY RECORDS

### A Valuable Resource

In the course of researching a number of family lines, I discovered that some family members had served in the army, and that some had given their lives for their country.

I decided to write to the Army, and found that these enquiries are dealt with by the Central Army Records Office in Melbourne. The responses I have received have been very interesting, as they have either told me when someone was killed or given details of their service, and I have chosen two of them to illustrate the type of response you may expect and also how to formulate your enquiry.

My grandfather, Thomas William Atwell survived the war and died on 24 July 1965 when I was a boy of 9 years. I knew he had been in the First World War, but nothing else. My cousin, Lynn Thomas Joseph, was only a name on a chart. I believed he had died in the war but that was about all I knew.

#### Procedure:

When writing to the Army, you must always state your relationship to the person, or they will write back to ask for it. If the person was killed in the war, there is usually no problem getting information. Where someone survived, you need to indicate when the person died, as the army quite correctly insists on the permission of the serviceman concerned where he is still alive.

I asked questions of the following type in each enquiry I made, which may serve as a guide to others:

1. date and place of enlistment
2. age at enlistment
3. next of kin nominated
4. dates and places of service
5. when they went overseas
6. when and where killed
7. medals awarded
8. any other details of a personal nature that could be released to me.

#### Responses:

In the case of my grandfather, I received a typewritten reply which answered the matters I had asked about, and also a nice surprise. He had not received an 'Anzac Commemorative Medallion', and his nearest living relative was entitled to accept it on his behalf. As a result, my grandmother received this medallion.

In the case of my cousin, I was given photocopies of the original documents held by the army and which contained the information I had requested. As you can see from the copies in this article, they are very informative and provide a lot of detail.

The Attestation Form gives details of age, enlistment, next of kin etc. The Casualty form tells of some of the troop movements and when Lynn lost his life.

I believe these documents speak for themselves.

The form entitled "Australian Imperial Force", which lists the issuing of medals to Lynn or his family, illustrates the extent that people went to in noting the sacrifice of those who were killed in the course of their duty. This includes photographs of the grave sent to the family and other items of interest to the family of the dead serviceman.

The reading of my grandfather's service details, particularly the discovery that he was wounded at Gallipoli on 25 April 1915, has made Anzac Day extremely meaningful to me. So whether you want to find out when a family member died in the forces, or how one of your people was involved in the making of history, the army is a very exciting source. Also noteworthy, is the fact that the information provided by the army is given to you at no charge! The response time for a full reply is 10-12 weeks, although you receive an acknowledgement almost immediately.

REMEMBER; clearly state your relationship to the person and give their full name to assist the army to find the right person for you.

A warrant has been granted by the Melbourne Bench against one JOSEPH SKATES for unlawfully taking or causing to be taken away, on 9th inst., SUSANNA JENKINSON, an unmarried girl, under the age of sixteen years, against the will and consent of her father, John Jenkinson, residing at Moonee Ponds. Skates is about 22 yrs of age, 6 ft 8½ in high, light complexion, dark hair and whiskers, rather long features, turns out one foot very much when walking, has a large wart on back of right hand, an Englishman, is accustomed to sawing; wore, when last seen, a plaid jumper. He was in Van Diemen's Land for some time, and his wife and her friends now reside there; he has also some relations residing at Moonee Ponds. The girl is 14½ yrs of age, 5 ft 2½ in high, swarthy complexion, very stout, dark brown hair and eyes, speaks with a rather broad English accent; wore a Tuscan bonnet, black lace veil, black silk mantle, brown alpaca frock and cloth boots. She took with her several brooches, rings and dresses. Ten Pounds reward on apprehension of Skates offered by Mr Jenkinson. Information to the Detective Office, Melbourne. Melb. 11 Oct 1855.

Information is requested respecting a gentleman named John JEFFREY or JEFFERSON who arrived in Melbourne in October 1852 by the Mobile, Capt Ponsorby, from Liverpool; was known at the Commercial Inn, Little Bourke St, Melb. #### National Language Policy Success

Thanks to the hard work put in by Aboriginal people across Australia, there is now a policy in place which recognizes Aboriginal languages. It points to the needs of Aboriginal people and their right to preserve these very old and important languages.

It is not generally known in the non-Aboriginal community that there were 500 different languages spoken across Australia at the time of white settlement. This vast number has now been reduced to about 140 which represents a massive loss to mankind of a great cultural treasure.

#### Briggs Family Reunion a Success

The reunion was held at the Latrobe Memorial Hall in November 1986 and was a great success. The event drew members from South Australia and Victoria and all of Tasmania.

The organizer, Mrs Molly Hamilton, deserves full credit for the success. She did much of the work herself; organized the hall, eats, visits to Dolly and Thomas Johnson's house at Frogmore, speakers at the meeting, lunch venues etc.

Dalrymple Mountgarret "Dolly" was the grand daughter of the Tasmanian Aboriginal Chief Mannalargenna. Her mother Woretermoetyenner, married George Briggs, a sealer, sailor who was said to be a "native of the colony" (probably born in NSW to English parents).

#### TAGHA Reunites Family

One of the most rewarding things anyone can do is to help someone find lost family. TAGHA has just completed helping a Tasmanian woman now living in Victoria to do just that. The young Aboriginal woman was placed in the care of a non-Aboriginal lady as a very young child. She only recalls visits from her now deceased grandfather and one other relative, who she recalled tried to help her when she was young. As she grew, she lost contact with all family and later moved to Victoria where she married, has a family and works.

TAGHA managed to locate many of her missing relatives who have since been reunited with her here in Tasmania. Tracing lost relatives is one of the many undertakings which TAGHA has taken on. This service is carried out on the understanding that relatives, once contacted, may not wish to meet with the enquirer for their own reasons and this request is upheld.

The first known record of Stephen White and his wife Peggy can be found in the book "Narrative of a Residence on the Island of Tristan D'Acunha in the South Atlantic Ocean" which is held in the Tasmanian State Library. Page 315 mentions Stephen as being "the last and youngest of our party" and states that he was a survivor of "The Blendenhall" Indiaman wrecked on a neighbouring island. White married Peggy on the Island where they had their first child (pp 316,338). A painting exists in the National Gallery Canberra, which depicts a scene on Tristan D'Acunha in which Stephen and Peggy appear.

The couple left the island and Stephen took Peggy, who was of Portugese-Indian descent, to England where they had a further four children. They arrived in Tasmania in June 1832 on the 'Rubicon'. The following year they had their first child in Tasmania, Charlotte, at Sorell.


Sarah d aged 15 years in 1841, James Henry's history is not known.

Research has shown that the couple came to Tasmania on the 'Royal Saxon' in 1842 from England with two of their children. A daughter, Sarah Ann, married a Henry Johnson in 1877 at Deloraine. There is no evidence to date confirming Aboriginal background. However, family members from different branches insist there is.

A photo of Ann and Henry Johnson is included to assist anyone who may have information which could be helpful. Sarah Ann was born at Delorsine in 1860, a brother Henry was born at Launceston 1848 and a sister Mary Ann in 1852 at Launceston. Others include Louisa, Elizabeth and Charles.

# *The Trouble with Names*

by A. Ralston

The trouble is that in Scotland, they had English forms and Gaelic forms and alternate spellings which were often interchanged. As for pet-names, nick-names, shortened forms ... these were used as well, especially if there were already five Margarets in the family and six Andrew Ralstons in the district. Nick-names, not usually appearing in official records, were quite personal and distinguished one James Brown from another - 'Long' Brown, 'Big' Jim, 'Young' James and so on.

Names appearing in birth and baptismal registers, might differ from those used by that person when recording other events for various reasons. Sometimes the informant of a birth or death, for example, was simply a messenger who might have got his facts muddled, hence Maud Mildred Gibson, as she was always known, was registered by the minister a few days after her birth as Mildred Maud Gibson. Sometimes the informant or records clerk got the dates wrong too, especially in the cases of deaths where details (such as where the deceased was born, number of dead and alive issue and marriage details were required) often were approximated simply because the informant really didn't quite know the true details. At times, the accent of the informant caused the records clerk to record quite strange spellings so Marion Freeberg grew up to be Mary Anne Freeborough alias Marian Freebairn alias Mary Fairburn. Matters were especially difficult when the records clerk was barely literate and the informant quite illiterate, thus when Beth Dun married Bill Kerr, their marriage was recorded as Elspeth Doune and Wm Carr. On their christening records, their names were spelt Elizabeth Dunn and William Ker.

The problem with spelling of names isn't confined to Christian names, those of properties, towns and surnames are just as variable but generally approximate the spoken word (if your accent is right!). There are deliberate cases of spelling change, such as 'posh Aunt Isobel Stuart', who adopted the Stuart spelling because she didn't want to be associated with 'those Stewarts who had offended her some eons ago' and anyway it sounded more French. Mind you many families have had an 'Aunt Isobel' who has provided great problems for later genealogists and it would serve her right if she got left off the family tree. The Macgregor surname was outlawed and owners of this surname adopted other surnames such as Grier and Grierson among many others, not remotely like Macgregor, in order to save their lives. Some quite ancient names are downright embarrassing, such as King Eystein 'The Fart' and Malcolm 'The Maiden' although the meanings of these descriptive names are open to variable interpretations and along with nick-names certainly add more colour to our ancient relatives.

So if you can't find cousin Belle under Isabel, perhaps she was Annabel and Juno may turn out to be great Uncle Jack! Here's a list to help.

1887-1987: THE FRIENDLY YEARS: THE FRIENDS SCHOOL Hugh Campbell

As part of its centenary celebrations, the Friends School in Hobart has produced an attractive 179 page record of the first century of its existence. The book contains at least one historical fact about each of the hundred years and, on the facing page, someone's reminiscence about most of them. Inevitably there is more detail about the last quarter of a century. There are many half-tone photographs of groups and individuals; for most of the early ones, no names are given.

In the main, genealogical interest in this book would be limited to people connected with the school or with the Society of Friends. It would be an excellent supplement to the history of an old scholar; and since so many names are mentioned in passing, there is a good chance of finding one of those interesting snippets of information that round out the story of an ancestor's life.
